5. Disqualification

No person.

a) Who has entered into or contracted a marriage with a person having a spouse living, or

b) Who, having a spouse living has entered into or contracted marriage with any other persons, shall be eligible for appointment to the said post.

Provided that the Governor of Mizoram may, if satisfied that such marriage is permissible under the personnel law applicable to the marriage and that there are other grounds for doing so, exempt any person from the operation of this Rule.

6. Training and Departmental Examination:

The person recruited under these Rules shall urdergo such training or pass such Departmental Examination as may be prescribed from time to time.

7. Transfer and : posting

Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest may transfer any Officer or Official, recruited in accordance with these Rules to the post/posts/service specified in the Annexure to these rules to any other post or position which is equivalent in rank or grade.

8. Power to relax:

Where the Governor of Mizoram is of the opinion that it is necessary or expedient so to do, he may by order and for reasons to be recorded in writing, relax any of the provisions of these Rules with respect to any class or category of persons.

9. Reservation other concessions:

Nothing in these rules shall effect reservation and other concessions required to be provided for the Scheduled Caste, Scheduled Tribes and other categories of persons in accordance with the orders issued by the State Government from time to time in this regards.

10. Repeal & Saving:

All the Rules pertaining to the recruitment to these posts still in force are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto shall be deemed to have been done or taken under the corresponding provisions of these rules.
