ORDER

In the interest of public service and in pursuance to the decision made by the high level committee held under the Chairmanship of the Hon'ble Minister, School Education Department on 7th July, 2021, the following instructions are issued for compliance with immediate effect and until further orders:-

- 1) Guidelines for Education during prevalence of Covid-19 pandemic has been adopted (vide Notification No. F.13011/1/2021-EDN dated 7.7.2021) and will be effective from 12.07.2021.
- 2) Consequent upon the adoption of the guidelines by the competent authorities, online/offline mode of teaching shall be taken up in earnest in order to continue education during COVID-19 pandemic.
- 3) Accordingly, principals, headmasters, teachers and staff of all schools including those schools owned by private, churches, NGOs are expected to be stationed in their respective schools by the 12th July, 2021 (Monday).
- 4) Schools shall remain open without students with effect from 12.07.2021. Detailed guidelines to this effect is issued separately.
- 5) Hard copy of the Guidelines shall be circulated to all schools in due course and soft copy of the same may be accessed from <https://schooleducation.mizoram.gov.in/> and <https://samagramizoram.nic.in/>
- 6) All existing guidelines for COVID Appropriate Behavior in force along with the standard operating procedure already issued by the department shall be strictly followed.
- 7) The process of opening schools without students and implementation of the guidelines shall not contravene any of the existing instructions on the fight against Covid-19 issued by the Government.
