NOTIFICATION

No. B. 13016/9/94-EDS, the 12th August 2002: Whereas the Government of Mizoram finds it expedient in public interest to amend the existing Mizoram Middle Schools and High Schools (Provincialisation) Rules, 1994, the Governor of Mizoram is pleased to amend the said Rules as follows:-

1. SHORT TITLE, EXTENT AND COMMENCEMENT:

- (1) These Rules may be called the Mizoram Middle Schools and High Schools (Provincialisation) (Amendment) Rules, 2002.
 - (2) They shall have the like extent as the Principal Rules.
 - (3) They shall come into force on the date of publication in the Mizoram Gazette.

2. AMENDMENT OF RULE 6:

In the Middle Schools and High Schools (Provincialisation) Rules, 1994 (hereinafter referred to as the Principal Rules) in rule 6, for the first, second and third provisos, the following provisos shall be substituted, namely:-

"Provided that the upper age limit prescribed in the relevant recruitment Rules shall cause no bar to any

of the teaching and non-teaching staff of the Provincialised Schools so absorbed.

Provided further that the existing Headmasters, who are not appointed Headmasters under this rule shall be appointed teachers at their respective provincialised Schools and shall be deemed to be employees of the Government with effect from the date of Provincialisation of the Schools subject to their suitability in consonance with the relevant recruitment rules as may be determined by the Departmental Promotion Committee".

3. AMENDMENT OF RULE 7:

In the Principal Rules, for clause (b) of Rule 7, the following clause shall be substituted, namely:-

"(b) For the purpose of fixation of interse-seniority in the services of the teaching and non-teaching staff of the provincialised school shall be counted with effect from the date of provincialisation of the school based on merit drawn by the selection Committee i.e., Mizoram Public Service Commission or Departmental Promotion Committee, as the case may be. In the absence of recommendation of the Selection Committee, the seniority in the past service immediately preceding the provincialisation of the concerned School shall be taken into account as a genuine seniority for the said purpose.
