

AGREEMENT FORM
(For engagement on casual Teacher)

Article of Agreement made on _____ between
Pi/Pu _____ of the first part and the
Governor of Mizoram (herein after called the Government) of the other part.

Whereas the Government has engaged the party of the first part as
_____ (name of
the post) and the party of the first part has agreed to serve the Government on the terms
and conditions herein after contained. Now these presents witness and the parties thereto
respectively agrees as follows :-

1. The party of the first part shall submit himself/herself to the orders of the Government and of the officers and authorities under whom he/she may, from time to time, be placed by the Government and shall remain in the service with effect from _____.
2. The party of the first part shall be entitled to a remuneration at the rate ₹ _____/- per day.
3. The party of the first part shall devote his/her whole time to his/her duties and at a time abide by the CCS (Conduct) Rules, 1964 and whenever required, proceed any part of India and there perform such duties as may be assigned to him/her.
4. The services of the party of the first part will be terminated :
 - a) automatically at the end of the engagement period unless extended by the Government
 - b) by the Government without previous notice if the Government is satisfied on medical evidence that the party of the first part is unfit for further service.
 - c) by giving 1 (one) month notice in writing at any time during service under this agreement by either of the party except as provided at (b) above
 - d) by the Government or their Officers having proper authority without any previous notice if the party of the first part is guilty of any insubordination, intemperance or other misconduct or any breach of any of the provisions of these presents or of any rules pertaining to the office of the public service to which he/she may belong or is found unsuitable for the efficient performance of his/her duties.
5. If the party of the first part be suspended from duty during investigation into any charge of misconduct mentioned in sub-clause (d) of clause 4 of these agreement, he/she shall not be entitled to any remuneration/fee during such period of suspension.

6. If the party of the first part is found liable for recovery of any amount due to the Government for loss or damage caused to Government properties or otherwise, the recovery will be effected from his/her remuneration.
7. The amount from time to time, payable to him/her under these agreements shall be paid for such period as he/she shall serve under this agreement and actually perform his/her duties (including Paid Holidays) commencing from the aforesaid date and ceasing on the date of his/her quitting service or on the date of his/her discharge there from or on the date of his/her death if he/she dies while in service.
8. The party of the first part shall be entitled to Maternity/Paternity/Casual Leave as admissible to Muster Roll Teacher under School Education Department issued by the Government from time to time.
