OFFICE ORDER

Consequent upon the declination of offer of engagement by some selected candidates and in continuation of this Office Order of even No. dated 1.11.2024, the following persons are hereby engaged to the post of **Casual Teacher (Middle School) at a fixed remuneration of ₹ 730/- per day** and posted to the schools shown against their names in the **Annexure** with effect from the date of their joining upto **28.02.2025** which may be extendable from time to time.

The engagement is purely temporary and may be terminated at any time without assigning any reason thereof and shall not bestow the right to claim continuation or regularization in his/her engagement. On expiry of the engagement period, the engagement shall stand automatically terminated without further notice unless extended by the Government.

Person willing to join the post shall submit his/her acceptance or otherwise to the Director of School Education within 5 (five) days from the date of issue of this order. Acceptance once submitted shall be final and not liable to change for any reason. The engagement order is valid only on signing of the Agreement Bond by the candidate followed by engagement card issued from Directorate of School Education.

Leave entitlement shall be the same as Muster Roll Teachers under School Education Department issued vide Office Order No. A.11017/4/2020-DSE(Est) Dt. 12.04.2023.

Further, in the interest of public service, the place of posting of the following **Casual Teachers (Middle School)** is hereby re-arranged as shown against their names in the **Annexure** with immediate effect and until further orders.


