OFFICE ORDER

In pursuance of the result notified vide No.A.11016/4/2022-DSE(Estt)/Pt/83-85 dt. 20.06.2024, the following persons from panel list are hereby engaged to the post of High School Casual Teacher at a fixed remuneration @ Rs. 730/- per day and posted to the schools shown against their names in the **Annexure-I** with effect from the date of their joining up to 30.06.2025 which may be extendable from time to time.

The engagement is purely temporary and may be terminated at any time without assigning any reason thereof and shall not bestow the right to claim continuation or regularization in his/her engagement. On expiry of the engagement period, the engagement shall stand automatically terminated without further notice unless extended by the Government.

Person willing to join the post shall submit his/her acceptance or otherwise to the Director of School Education within 5(five) days from the date of issue of this order. Acceptance or otherwise once submitted shall be final and not liable to change for any reason. The engagement order is valid only on signing of the Agreement Bond by the candidate followed by engagement card issued from Directorate of School Education.

Leave entitlement shall be the same as Muster Roll Teachers under School Education Department issued vide Office Order No.A.11017/4/2020-DSE(Estt) Dt.12.04.2023.

They should join their place of posting within 15 days from the date of issue of this order.

Consequent upon the issue of this order, the High School Casual Teachers as enclosed in the **Annexure-II** are hereby transferred to the post shown against their names.

They shall be released within 15 days from the issue of this order.


