GUIDELINES FOR EDUCATION DURING PREVALENCE OF COVID-19 PANDEMIC

MIZO TAWNG – PART 'A' ONLY

1. INTRODUCTION:

Covid-19 hri lengin Mizoram mai ni lo khawvel pumpuia a chhe zawnga a ngawng nasat berte zing a mi chu zirna hi a ni. Hun rei tak chhung sikul khar a nih tak avangin state tinah naupangte zirna nasa taka tih bahlahin a awm a. Tun hnai maia zir chiannaa a lan dan chuan Mizorama naupang 241107 zet mai te zirna chu he hrileng hian a nghawng ni a chhut a ni. He hripui hi engtikah nge hnehin a awm ang tih sawi theih a nih loh avangin, zirtirna kan pek thin dan pangngai (conventional system – face to face) ni lo, kawng dang kan zawn a ngai ta a ni. Tun dinhmunah chuan naupangte nen hmun leh hmuna zirtirna kalpui a rem ta lo va, chutih rualin kan rama naupang sang tam takte zirna he hripui avanga a sukuk zel loh nan ngaihtuahna thar sengin, in zirtir dante tih danglama, online emaw a chang changa online emaw leh offline-te hmang kawpa tha taka zirtirna pek dan zawn a lo ngai ta a ni.

Duhthlan tur dang a awm loh avangin sikul tam takte chuan online-in zirna an kalpui a. He inzirtir dan thar hian classroom chhunga inzirtirna chu tluk lo mah se mimal tinte mahni remchan dan ang zela zirna kalpui tura siamrem theih a nihna hi a thatna a ni. Chutih rualin, thuneitu sang leh sorkar lam atanga online kalpui dantur kaihhruaina mumal a awm loh avangin nakin zelah zirtirna kawngah ngawng tha lo a awm palh thei. Ram pumpuiah online zirtirna hi kan kalpui dawn chuan, hmanrua hman theih awmte, internet connection awmna hmun anih leh nih lohte ngun taka ngaituah a ngai a. Tunhnaia zirchianna neihah online zirtirna chauh hman hian naupang thenkhat tan harsatna a thlen tih a ti lang.

- 1.1 April/May 2021-a Samagra Shiksha ten zirchianna an neih 'Access to Digital Devices' a a landan chuan zirlai naupang 38.31% ten zirna tur hmanrua an nei lo va. Primary section bikah naupang 50.33% ten an nei lo bawk. Chipchiar zawkin Annexure-1-ah tarlan a ni.
- 1.2 Covid-19 hripui lenlaia online zirtirna hmasawn theih nana rawtna siam turin Sorkar chuan Committee a din a, chu committee chuan DEO leh SDEO te kaltlanga Mizoram internet dinhmun zirchiangin, khaw tam takin harsatna an tawk tih an tarlang. Khaw tam takin signal an neih that loh avangin Online zirtirna kalpui an harsat thu an sawi bawk. Chipchiar zawkin Annexure-2 ah tarlan a ni.
- 1.3 Heng zirchianna pahnih atang hian technology hmanrua hian naupangten zirna an dawn kawngah daidaina/inthliarna a thlen tih a lang a. Heng indaidanna/inthliarnate hi kaihhruaina felfai tak (online emaw, offline maw) hmangin thiah a ngai a, zirtirtuten naupang tin zirtirna an pek theih nan heng - portal, apps, telecast/broadcast, Websites, YouTube, print resources, textbook leh zirlai tanpui thei hmanraw dangte an hman tangkai dan tur zawn a ngai ta hle tih a tarlang tel bawk awm e.
- 1.4 He zirtirna dan thar (online zirtirna) hlawhtling tur chuan nu leh pa, khawtlang hruaitute, leh tlawmngai pawl hrang hrangten mumal taka ruahmanna an siam a, an en tlithlai ui a, an tanho ngai a. Chu mai bakah, zirtirtu leh nu leh pa ten rilru inhawng taka he zirdan thar hi an pawm a, a taka kalpui thei tura an lo inpeih hi thil pawimawh tak a ni bawk.

2. ZIRLAI HMANRUA NEI LEH NEI LO THEN HRANNA:

Online leh offline zirtirna hlenchhuaha nih theih nan, zirlai naupangte chu a tlangpuiin ahnuia mi ang hian hlawm hrang paruk ah then theih an ni.

2.1 Chhungkua device (hmanrua) nei leh nei lo:

- i. Computer/Laptop/Smartphone (4G)/
Cable TV nei te.
- ii. Smartphone (4G) nei te.
- iii. Smartphone (3G/2G chauh hmang thei) emaw internet hmang thei lo te.
- iv. Cable TV nei te.
- v. Radio emaw, mobile phone a radio awmtel nei te.
- vi. Device (hmanrua) nei lo te.



Chhungkua achunga tarlan hmanrua pakhat chauh nei emaw nei miah lote tan online, online zeuh zeuh emaw offline emaw hmanga zirtirna pek dan tur ruahman a ngai ta a. Online zirtir dan hi chi hniih awmin, sikulte chuan an zirlaiten an tih theih chin ngaihtuah chungin, inbuktawk tak sia zirtir dan an siam a ngai a ni.

- **Synchronous:** Hetiang zirtirna ah hian zirlaite (huho emaw, mimal emaw) leh zirtirtute chu a rualin an in be thei a, ngaidante an sawi ho thei a ni. Synchronos zirtirna pek theih dan thenkhat te chu – satellite emaw telecommunication hmanga video conference (alang ve ve a inbiaktawn chi te, video-a pakhat zawk chauh lang chi te) leh aw chauh hmanga inbiak te a ni.
- **Asynchronous:** Hetiang zirtirna hi chu khawi hmunah pawh, engtik hunah pawh pek/hman theih a ni. Entirnan: e-Mail, SMS, MMS, DIKSHA-a e-content, radio/podcasts ngaihthlak, TV en te.


Sikulte hian synchronous zirna hi digital learning hlawhtlin theihna awm chhunah ngaih ngawt tur a ni lova. Classroom chhunga hmaichhana inzirtirna kalpui dan dan anga internet kaltlanga tih ve kher hi tum ber tur a ni hek lo. Eng hunah pawh, khawi hmunah pawh hman theih online leh offline zirtirna chawhpawl hian zirlaite mahni inhai kaw thei tura puiin, kawng tinrengah hmasawna a pe a, classroom-a hman theihloh hmanrua leh ruahmanna dangte hman thiamna hun remchang a siam sak.

3. DIGITAL/KHAWLTHIL HMANGA ZIRNA KALPUI DAN:

Khawl thil hmanga zirna kalpui dawn chuan zirlaite dinhmun hrang hrang leh khawlthil awm remchangte hre reng chungin ruahmanna siam tur a ni a. Chung ruahmanna zinga mi, an tana remchang ber chu thlangin an lo hmang mai dawn a ni.

3.1 Online Mode:

Computer/smart phone a internet connection neite chuan heng zinga mi an duh ber hi an thlang thei ang.



Model 1:

Zirtirtuten message/mail etc hmangin zirlaite kaihruai tura an buatsaih zirtur an thawn ang a. Zirlaite chuan lo en lawkin, video hmanga inbiakna an neih hunah, zawhna an neihte zawtin, an sawi ho ang.

Model 2:

Hmanrua engemaw ber hmangin video class neih hun tur ruat lawkin class an neihpui ang.

Model 3:

Learning Management System (LMS) hmangin live class neih hun tur an ruahman a, zirlai ten forum/group emaw kaltlangin zirhona hun neih tur a ni. LMS ah hian zirna pui theitu hmanruate in pe tawnin, assignment-te thehluh theih a ni bawk.

3.2 Partially Online Mode (A changa online):

Computer/smart phone nei, internet connection nei mumal si lo te chuan heng zinga mi engemw ber hi an thlang thei ang.

Model 1:

Zirtirtuten messenger/email etc hmangin zirna pui thei tu tur link-DIKSHA/epathsala/NROER/NDL emaw mitin hman theih tura awm platform dangte chu zirlai leh nu leh pate hnenah an thawn ang. Hengte hi zirlaiten pendrive/phone/computer-ah te offline-a hman atan an lo download ang. Heng bakah inchhiar zauna turin zirtirtu ten chhiartur dang an hrilh bawk ang.

Model 2:

Zirtirtu in zirlaite an zirlaibu bakah chhiar zau tur dang awm remchangte a kawhhmuh ang a, kar khatah vawikhat heng whatsapp, phone call, video calle hmang hian naupangte nen inbia in, inzirtirna hun an hmang ang.

Model 3:

Class tinte tan an zirlai mek mil ang zela pui thei tur in zirtirna video, hrilhfiahna DVD/CD zirlaite tiphir thei tur an thawn/entir thin ang. En zawahah zirtirtu chuan online-in naupang zawnate chhangin an hriatthiam lohte a hrilhfiah leh ang. (Kar khatah vawi khat tal).

3.3 Offline Mode

Hmun thenkhat internet connection awm lohna leh chiangkuan lohna ahte chuan internet hman ngai lo hmanraw dang TV, Radio leh a dangte hmanga zirtirna pek thin a ni. Thu ziak sa (printed) hmangte pawhin offline zirna hi kalpui theih a ni.

TELEVISION HMANGIN

Model 1:

TV channel (DTH leh cable TV) ah te chuan class tina topic-te chu pek chhuah a ni a. Hemi avang hian naupang ten awlsam takin mahni inlum atangin an zir thei a ni.

Model 2:

Pendrive/DVD/CD hmanga class tinte tana zirtirna pek chhuah.

Model 3:

Zirlaiten an puala TV an neih mumal lohna hmun ah chuan vantlang TV hmangin zirlaite tan a huhova zirtirna pek theih a ni.

RADIO HMANGIN

Model 1:

AIR nen tang dunin Radio hmangin class tin zirlaite pekchhuah theih a ni.

Model 2:

Khawtlang /FM Radio channel-te hmangin zirna pui thei tur hmanrua te chu naupang mamawh ang zela siam remin pek chhuah theih a ni.

Model 3:

Zirlaiten an puala radio an neih mumal lohna hmunah chuan vantlang radio hmangin zirlaite tan a huhova zirtirna pek theih a ni.

THUZIAK AWMSA HMAN

Phase 1: Zirlaibu hmangin

An zirlaite an thiam bel theih nan zirtirtuin chapter tawpah emaw a remchan dan angin tihtur an zirlaibu behchhanin a siam ang a, a pe tur a ni. Hei hian zirlaite thiam chin chu zirtirtute a hriatchiantir ang a, an harsatnah an tanpui thei dawn a ni.

Phase 4: An thiam leh thiam loh tehna

Zirlai atanga an thiam tur an thiam chhuak em tih chu ngaih pawimawh ber tur a ni. Naupang tinin a zirlai a thiam leh thiam loh teh nan test paper leh practical in zawnate pek thin tur a ni a. Academic Work Plan for Home Learning 2021-2022 for elementary schools leh The Week-Wise Plan for Secondary Schools milin test hunbi siam tur a ni.

Phase 5: Endik/vil

Eng programme pawh hlawhtling tur chuan ngun taka enpui leh vil hi a pawimawh em em a, chuvangin endik dan leh vil dan hi mumal taka kalpui tur a ni. Endik dan leh vil dan chuan heng thil pahnih Academic monitoring leh physical monitoring te hi a huam tel tur a ni. Endiktute chuan heng thil pahnithe hi ngaipawimawhin a zing thei ang berin an endik thin tur a ni.

4. ONLINE/ PARTIALLY ONLINE/OFFLINE ZIRTIRNA PEK DAN KALPHUNG INDAWT PARIATTE

Zirna kalpui chhunzawm zel nana Online/Partially Online/Offline hmanga zirtirna inpek dan kalphung indawt (steps) 8 a awm a, chungte:

4.1 Planning – Heng a hnuia mite hre chung hian ruahmanna siam tur a ni.

- Naupangte zir thiam dan zawng
- An zirlai hriatchian
- Naupang, zirtirtu leh sikulin khawl (digital device) thil an neih dan hriat
- Zirtirna pek hun chhung
- Naupangte tihtur leh a tehfung

4.2 Identification – Online class kalpui thei tura hmanraw mamawhte hriatchian. Hei hian class tin rei zawngte, cyber security te, tehfung kalpui dan tur etc te a huam.

4.3 Arrangement – Class neih dan tur siam rem.

4.4 Guidance – A tantir te atangin zirtirna in a kaihhnawih zawng zawngte hnenah kaihhruaina pek tur a ni. A tel awm zawng zawngte teltir leh an hriat tur awm hrilhfiah hi a pawimawh em em a. Chuvangin, sikul chuan zirtirtute mai bakah, zirlaite leh an nu leh pate chu naupang zirlai chungchangah te, an topic zir turte, an tehdan kalhmang leh thil pawimawh dangte hrilhriain a kaihruai thin tur a ni.

4.5 Communication – Zirtirtu, nu leh pate leh an fate inkarah inbiakpawhna tha tak a awm tur a ni.

4.6 Assign – Mimal emaw a huhova tihturte chu an hmanraw neih dan azira pek tur a ni.

4.7 Monitor – Zirlaite an inthlahdah loh nan zirtirtu ten zirlaite hmasawnna leh thlen chinte endik fo chungin tihtur an tuksak thin tur a ni.

4.8 Appreciate – Online/offline zirna avanga zirlaite an hnual mai loh nan, zirtirtute chuan zirlaite chu fak in mahni inrintawka an neiha, an zirlai an tuipui zel theihna turin an chawkphur thin tur a ni.

5. HEAD, ZIRTIRTU, NU LEH PA LEH ZIRLAITE KAIHHRUAINA

5.1. Sikul Head (Headmaster/Principal) leh Zirtirtute (Teachers) kaihhruaina

Zirtirtute hian naupang nunah hian hmun pawimawh tak an luah a, an tawngkam leh chetzia hmangin naupangte chu ngaihsaknate, hmangaihnate, duhsaknate leh kaihhruaina te an pe thei a ni. Hei vang hian digital platform hrang hrang hmanga zirtirna an pek naah an tawngkam leh cheziaah te an fimkhur a ngai hle a ni. Hemi mai bakah hian an zirlaite rilru leh taksa hriselna kawngah zirtirtu te hian mawhphurna sang tak an nei bawk.

5.1.1 Mamawh hriatchian hmasak (Need Assessment)

- Sikul hotuten inlama naupang tin ten zirna atana hmanraw pawimawh (ICT facilities) an neih dan hriat chian tumin, chumi hmang chuan pawlah thenin emaw ruahmanna dang siam nan an hmang thei ang.
- Class tina zirtirtu leh zirlaite tan (i) inbiakpawhna dan tur (ii) zirtir dan tur (iii) naupangte pui thei turte ngaihtuah tur a ni.

5.1.2 Ruahmanna (Planning)

- Sikul head-te chuan heng ICT hmanrua (laptop/tablet/internet/etc.) zirtirtu ten an hman theih dan tur ngaihtuahpuin, tha taka an hman theihna tura fuih chung zelin hma an hruai ang.
- Digital technology hmanga zirtirna kalpui dan tur leh hman dan turte hi an hman tantirh dawnin zirtirtu, nu leh pa leh zirlaite hnehah hrilhfiah a, a tul dan azira hrilh nawn leh thin tur a ni.
- Head chuan zirtirtute chu nikhatah rei tak (darkar 6 – 8) zirtirna pe turin a beisei tur a ni lo a, ni khatah darkar 2 – 3 a tawk a. Amaherawhchu, zirtirtu chu a zirlaite leh nu leh pa ten an hlawkpui theih tur kawng dapin, zir turte siamin a inzir chhunzawm reng thei a ni.
- Awlsam taka inbiak pawh zung zungna turin zirtirtu, nu leh pa leh zirlaite telna class tin tan group (thu thawn theihna) siam tur a ni. Pawl hniam zawkah erawh chuan zirlaite aiawhin an nu leh paten an be pawp thei ang.

- Digital hmanga zirtirna hian zirlaite leh nu leh pate tan phurrit a siam tur a ni lo. Zirlai tan leh nangma (zirtirtu) tan pawha thlen phak loh tur ruahmanna sang tak tak siam loh hram tum tur a ni.
- Digital hmanga zirna kalpui dan ruahmannaah zirtitute leh nu leh pa aiawhte an tel thin tur a ni. Zirtirtu zawng zawng rawn chungin class tin tan time table felfai tak (online leh offline a tih tur) siam tur a ni.
- Zirlai zagh tuma hmanhmawh mai lovin, an zirtur dik tak zir chhuah tir tum tur a ni. Zirlaite phaktawk, kum, hmanraw neihte leh an zir chhuah tur duante ngaituah chunga ruahmanna siam tur.
- Nitina zirlaiten an hman tangkai theih tur life skills zir chhuah theihna tur ruahmanna ICT hmangin siam tur a ni.
- Digital hmanruate hi naupangin reitak an khawih chuan an hriselna atan a pawi thei a. Chuvang chuan an kum mil zelin an zir tur duan tur a ni.
- A theih hram chuan nu leh pa leh chhungte chu naupang zir nana hmanraw hman tur remchang thlan naah an tel ve thin tur a ni.

5.1.6 Internet him taka hman dan

RECOMMENDATIONS – OPERATIONAL GUIDELINES FOR IMPLEMENTATION OF GUIDELINES FOR EDUCATION DURING COVID-19 PANDEMIC

For successful implementation of Guidelines for Education during Prevalence of Covid-19 Pandemic, the committee recommends the following for consideration of the Government.

Education during pandemic requires coordinated efforts of all stakeholders and effective supervision and monitoring at all levels. To create this platform in which participation of the key functionaries may be ensured, it is considered necessary to constitute committees at the State level and local level to whom the powers and functions of State Level Committee may be delegated for the successful implementation of the Guidelines. Hence, committees as given hereunder may be constituted as soon as the guidelines are notified for information of the general public.

1. STATE LEVEL COMMITTEE FOR EDUCATION DURING PREVALENCE OF COVID-19 PANDEMIC:

- (a) They shall be a State Level Committee to be called State Level Committee for Education During Prevalence of Covid-19 Pandemic under the Chairmanship of an officer not below the rank of Joint Secretary in the State Government, preferably Secretary to the Government of Mizoram, School Education Department to monitor and supervise implementation of Guidelines for Education during Covid-19 Pandemic. This committee may be consisted of the membership of the following stakeholders:
- i. Representatives from Directorate of School Education
 - ii. Representatives from Directorate of SCERT, Mizoram,

- iii. Representatives from MBSE
 - iv. Representatives from Samagra Shiksha, Mizoram
 - v. Representatives of MTF and MISA
 - vi. Representatives of ICT Department
 - vii. Representatives of Education Department, MZU
- (b) The State Level Committee shall be the apex body for Education during Prevalence of Covid-19 Pandemic and shall be responsible for the effective implementation Page 2 of 6 of the Guidelines with support from all offices under School Education Department like Directorates and field offices. The committee may delegate powers and responsibilities to Director of School Education, Director, SCERT and Chairman, MBSE as may be deemed necessary.

2. LOCAL LEVEL COMMITTEE FOR EDUCATION DURING PREVALENCE OF COVID-19 PANDEMIC:

- (a) There shall be a Local Level Committee for Education during Prevalence of Covid-19 Pandemic under the chairmanship of Chairman, Local Council or President, Village Council as the case may be. Recommended body of the committee is as given below:
 - i. Chairman, LC/VCP – Chairman
 - ii. Representative of Branch YMA – Vice Chairman
 - iii. Two members each of Representatives from –
 - o Teachers
 - o Parents
 - iv. Educationist
 - v. Volunteer (if any)
 - vi. Member Secretary (to be appointed by the committee)
- (b) The committee may appoint Member Secretary from amongst Headmaster or Senior Teachers of Govt. Schools within the locality in addition to Teachers' Representative in already nominated in the committee.

- (c) The committee may appoint Member Secretary from amongst Headmaster or Senior Teachers of Govt. Schools within the locality in addition to Teachers' Representative in already nominated in the committee.
- (d) Initially, Chairman and Vice Chairman of the committee may select Teachers Representative, Parents Representative and Educationist within the locality after which Member Secretary may be appointed in the first meeting of the committee.
- (e) The Local Level Committee shall be responsible for the following:
 - i. Ensure availability of textbooks/TLM for all students in the area
 - ii. Creating conducive environment of smooth and effective learning at home for all students.
 - iii. Distribution and collection of Textbooks/TLM, reports, student worksheets and Test papers.
 - iv. Sensitization of students regarding Covid Appropriate Behaviour (CAB),SOPs and safety and preventive steps against the pandemic.
 - v. Organize co-curricular activities like Quiz/Debate, Painting, Essay/slogan writing, painting and story writing etc.
 - vi. Watchdog for implementation of Guidelines for education during pandemic.
 - vii. Review the performance of schools within their jurisdiction in the implementation of guidelines based on the Monitoring Report.

3. DUTIES AND RESPONSIBILITIES OF OFFICIALS IN THE IMPLEMENTATION OF THE GUIDELINES FOR EDUCATION DURING COVID-19 PANDEMIC:

(a) Directorate of School Education:

- (i) Administering Monthly Monitoring format prepared by SCERT and MBSE for schools and field offices and enforce executive powers and control over officers under his control to ensure regular submission of monitoring report
- (ii) Collect and consolidate Monitoring Report for submission to the State Level Committee
- (iii) Develop specific Standard Operating Procedure (SOP) educational activities during Covid-19 pandemic and enforce the same

- (iv) Ensure availability of manpower resources to carry out all activities required by the Guidelines.
- (v) Ensure timely distribution of Midday Meal during School closure due to pandemic

(b) Directorate of SCERT, Mizoram:

- (i) Develop Monthly Monitoring Format for all Elementary Schools
- (ii) Development and review of Academic Work Plan for Home Learning
- (iii) Develop supplementary learning material whenever required
- (iv) Develop Play-based kit for Pre-School
- (v) Providing technical support to the State Level Committee in all

(c) Mizoram Board of School Education:

- (i) Develop Week-wise Plan for all Secondary and Higher Secondary Schools
- (ii) Develop Monthly Monitoring Format for all Secondary Schools and Higher Secondary Schools
- (iii) Providing technical support to the State Level Committee in all matters pertaining to academic activities of Secondary and Higher Secondary Schools
- (iv) All matters relating to assessment and evaluation relating to Secondary and Higher Secondary Schools

(d) State Project Director, Samagra Shiksha, Mizoram:

- (i) Financial Support for implementation of Guidelines for Education during Prevalence of Covid-19 Pandemic
- (ii) Prepare and deploy all field officers and staff for implementation of Guidelines as may be required
- (iii) Providing reliable statistics to State Level Committee
- (iv) All matters relating to documentation and publicity

SUMMARY OF SURVEY REPORT WITH RESPECT TO CONNECTIVITY

1. A Survey on Access to Digital Devices by Samagra Shiksha in April/May 2021 shows that there is 38.31% percentage of students without device across the sections of School Education. There are 50.33% of children without device in the Primary section alone. A table showing detailed information is shown as follows:

The Committee constituted by the Government to make suggestions for Improvement of Online Education during Prevalence of Covid-19 pandemic conducted a survey on the status of internet connectivity in Mizoram; results show that there are many villages where internet connectivity is an issue. insufficient signal strength coming in the way of online classes are also submitted by many villages. A complete report of the survey is shown in the following table.

ACTIONS TAKEN BY VARIOUS STAKEHOLDERS TO IMPLEMENT ONLINE/OFFLINE EDUCATION DURING 2020 - 2021 ACADEMIC SESSION

Owing to the COVID 19 pandemic, schools could not commence as usual in the 2020-21 academic session. Hence, several initiatives were undertaken by the various sectors under the education department to ensure that teaching and learning would continue as smoothly as possible.

A. INITIATIVES TAKEN FOR CHILDREN WITHOUT DEVICES

B. INITIATIVES TAKEN FOR CHILDREN WITH DEVICES

- I. PREPARATION OF TUTORIAL VIDEO CLIP:** The Media Cell of the Directorate of School Education and the Directorate of SCERT in collaboration initiated preparation of tutorial clips with contribution from Elementary School Teachers, High School Teachers and Higher Secondary School Lecturers. 161 Tutorial video clips for all subjects at the secondary school level were prepared by MISSTA.
- II. BROADCAST/DISSEMINATION OF THE PROGRAMME THROUGH ELECTRONIC MEDIA:** Telecasting of Tutorial Classes for Elementary and Secondary School Students through DDK, Aizawl, and two private TV channels (Zonet & LPS) was started. Students in remote areas and urban areas could receive the programme equally.

- IV. COMPACT DISC:** Some of the contents of Tutorial Videos (Class IX and X- Science and Mathematics) was written in Compact Discs and distributed to all the District **Education** Offices and all the DEOs circulated the same in all the concerned Schools which greatly helped both the teachers and students in the rural and remote areas.
- V. EDUCATIONAL TV PROGRAMME:** The School Education Department, Government of Mizoram also started an Educational TV programme known as Zirna Huang which was telecast by DDK, Aizawl. Through this programme, various activities of the Department including Tutorial Video Clips were publicized and disseminated for the public interest.
- VI. MISSTA ACADEMIC CHANNEL:** Apart from the programme, each subject at the secondary level in Class 9 and class 10 were also uploaded in the MISSTA ACADEMIC Channel.
- VII. BOARD EXAMINATION:** In Mizoram, amidst COVID-19 Pandemic, Board Examinations viz. High School Leaving Certificate Examination, 2021, and Higher Secondary School Leaving Certificate Examination 2021 were conducted successfully throughout the state following the Government's SOP strictly.

- VIII. USAGE OF GOOGLE CLASSROOM:** Google classroom was used extensively at the secondary and higher secondary school levels for uploading tutorials by the teachers, handing out of study materials and handing of assignments, test/assignment questions by the teachers and the respective answer paper by the students.
- IX. USAGE OF ZOOM/GOOGLE MEET:** Zoom/Google meet were also used for virtual classroom teaching as well as for oral tests and for clarification of doubts by the students at the secondary and higher secondary levels.
- X. USAGE of WHATSAPP:** Formation of WhatsApp groups by the subject teachers was a common occurrence among the secondary and higher secondary schools for subject related matters and inquiry.
- XI. ONLINE EDU CHALLENGE:** The Online Edu Challenge programme was initiated by the SCERT in April & May, 2020, as a weekly activity to ensure that children and teachers utilise their time in a meaningful manner during the lockdown period.

C. TEACHER CAPACITY-BUILDING:

- I. NISHTHA on DIKSHA:** SCERT Mizoram launched the NISHTHA training programme on the DIKSHA portal on 15th October 2020 which concluded on 15th January 2021 in 6 batches. No. of Teachers who have completed NISHTHA training **6522** against the target of **8951 teachers in face-to-face mode** and **2607** against the target of **2250 teachers in online mode**.
- II. 6-Month Certificate Course in Early Childhood Care and Education:** A 6-month Certificate Course on Early Childhood Care and Education (ECCE) for in-service teachers due to be launched in March was initiated online on 1st May 2020 and was completed in blended mode on 30th March 2021. Late completion of the course is due to disruptions brought on by the COVID-19 pandemic. 26 Elementary school teachers completed the course.

- III. Online School Health and Wellness Programme:** Capacity-building Programmes in 3 Districts (Mamit, Champhai, and Siaha) was conducted during March 2021 for School Health and Wellness Ambassadors (Heads and Teachers of High Schools) in online mode in collaboration with MoHFW under the aegis of Ayushman Bharat.
- IV. 6-Month Certificate Course in English Language Teaching:** The first batch of 6-month Certificate Course in English Language Teaching (ELT) for in-service teachers was initiated on 3rd November 2019 and was completed on 5th February 2021 under severe restrictions imposed by Lockdown during the pandemic.
