In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post (s) of Middle School Teacher under Education & Human Resources Development Department (School Education), Government of Mizoram, namely :-

- Nothing in these rules shall affect any resensations Short title and 1. (1) These Rules may be called the Mizoram Education & Human Resources Development Department (School Education) (Group 'B' post) Recruitment Rules, 2003.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

Application 2. The Rules shall apply to the posts specified in column 1 of the First Schedule hereto annexed.

Number of posts, 1312 The number of the said post(s), their classification and classification and the scale of pay attached thereto shall be as specified in scale of pay. Columns 2—4 of the First Schedule as aforesaid.

Disqualification 5. No person -

-nitation A demos(a) Who has entered into or contracted a marriage with ampoind sylla person having a spouse living, or

who, having a spouse living, has entered into or contracted a marriage with any person shall (b) eligible for appointment to the said post (s).

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation

Every Government servant recruited under these rules shall undergo such training or pass such departmental examination as may be prescribed from time to time. Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest shall have the right and power to transfer any officers so recruited under these Rules to any other post or position which is equivalent in rank or grade.

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing in consultation with the Department of Personnel and Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category of persons.

Nothing in these rules shall affect any reservations or other concessions required to be provided for the Scheduled Castes/Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time in this regards.

All the Rules pertaining to the recruitment to these posts still in force issued vide Notification No. F.E. 60/74-75/36-41 dt. 10.4.1975 and No.A. 12018/53/80-APT(B) dt. 19.11.1993 and published in the Mizoram Gazette Issue No 8 dt. 20.2.1976 and Issue No. 266 dt. 21.12.1993 in respect of the post of Assistant Teacher of M.E. School are hereby repealed.
