#### NOTIFICATION

No.A.12018/14/89-APT(B)Vol.II, the 12th September, 1996. In exercise of the power conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rule; relating to the recruitment to the post of Joint Director of School Education.

- and commencement.
- 1. Short title : i) These Rules may be called the Mizoram Education & Hu man Resources Department. (Group 'A' posts) Recruitmen Rules, 1996.
  - ii) They shall come into force on the date of their publication in the Mizoram Gazette.
- 2. Applica- : tion.

The Rules shall apply to the post specified in Col. I of the Annexure - I hereto annexed.

Number of posts. classification & Scale of pay

The number of the said post(s) their classification and the scale of pay attached thereto shall be as specified in the Annexure - I aforesaid.

4. Method of: recruitment. age limit and other qualifications

The age limit, qualification and other matters relating to the said post, shall be as specified in the Annexure - I.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Government of Mizoram from time to time.

#### 5. Disqua- : lification

No person,

who has entered into or contracted a marriage with a perso having a spouse living,

O.

b) who, having a spouse living, has entered into or contracted a marriage with any other persons, shall be eligible for appointment to the said post.

Provided that the Governor of Mizoram may, if satisfied that such marriage is permissible under the personnel law applicable to the marriage and that there are other ground for doing so, exempt any person from the operation of these rules.

## 6. Training: and Departmental Examination.

The person recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

- (a) Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest, have the right and power to transfer any Officer or Official recruited in accordance with these Rules to the post/posts service specified in Schedule/ Annexure to these rules to any other post or position which is equivalent in rank or grade.
- 7. Power to : relax

Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, in consultation with the Selection Committee through the Department of Personnel & Administration Reforms, relax any of the provisions and these Rules with respect to any class or category of persons.

8. Reservation, other concessions: Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central/State Government from time to time in this regard:

9. Repeal & Saving

All the Rules pertaining to the recruitment to these posts vide No. A.12018/14(i)/80-APT(B) Dt. 17.11.1987 read with subsequent amendment vide No. A. 12018/7/89-P&AR(GSW) Dt. 23. 1. 1996 and Recruitment Rules for the post of Jt. Director, Adult Education Noticed vide No. A. 12018/14/80-APT(B) Dt. 31.5.1993 still in force are acresy repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been done or taken under the corresponding provisions of these rules.
