**OFFICE ORDER**

Provisional Permission is hereby granted for opening and establishment of **St. Paul's Secondary School (Arts Stream), Monfort Hills, Tlangnuam, Aizawl** with immediate effect on the condition that the School should have qualified Teachers (*i.e. B.Ed.*) within 5(*five*) years and subject to fulfillment of conditions as laid down in the Annexure attached herewith within 2(*two*) years from the date of issue of this order failing which the permission is liable to be cancelled. The School should apply final permission after 5 years or having the prescribed qualification as required by the conditions whichever is earlier.

The School should be established and governed in accordance with the Mizoram Education (*Establishment & Management of Private H.S.S.*) Rules, 2006. Failure to comply with the rules shall entail cancellation of permission.

The permission shall not bestow on the School any right to claim financial aids from the Government.

This is issued with the approval of the Govt. of Mizoram, School Education Department vide letter **No. B. 17011/22/2023 – EDN** dated **20.12.2023**.

Change of name and location of the School is not permitted without prior approval of the Government.


