To take up such a huge and important task, the Government of Mizoram hereby constitute a committee called the 'Mizoram Education Reforms Committee' with the following composition:-

TERMS OF REFERENCE OF EDUCATION REFORMS COMMITTEE

- i. To examine the current status and condition of education in Mizoram which would cover all aspects of education such as – pre-school education, elementary education (primary and middle levels), secondary education (high school and higher secondary levels), higher education and technical education;
- ii. To examine the current status and condition of Private schools and make recommendation on re-defining the role of Government in controlling the functioning of private schools, including pre-schools.
- iii. To examine financial aid given to private schools (Lump-sum, Provisional Adhoc/Adhoc, Deficit) and make recommendations to revise existing rules and current system of disbursement of Grant-in-Aid.
- iv. To examine and suggest policies for improving the quality of education in order to make students globally competent.

- v. To examine and suggest policies that support inclusive education for students with special needs and to ensure equal access to quality education;
- vi. To examine different Acts, Rules, Regulations and orders governing the operation of education in Mizoram and make recommendations for change, revision or amendments;
- vii. To review and find ways of improving the role of Mizoram Board of School Education, State Council of Educational Research and Training (Mizoram), Indira Gandhi National Open University Study Centre at Aizawl and State Advisory Board of Education;
- viii. To suggest ways to re-structure, at all levels, from pre-school education to higher education by making all necessary changes, including recruitment processes and other allied matters in line with NEP 2020;
- ix. To examine and suggest ways to reform department organizational structure/ levels from School to Directorate levels including Centrally Sponsored Schemes.
- x. To examine and make recommendations for framing teacher's recruitment policy at all levels of education.
- xi. In a nutshell, to examine ways and means to offer quality education affordable to the poor, to find a solution to the increasing unemployment through education reforms in Mizoram and to frame an education policy to cover all aspects of education in the state.
